Research Projects:

Emotive Brainstorming (2012-15)

I am the Principal Investigator of a research consortium which is funded by the European Union, ICT (Information and Communication Technologies) (3.3 million Euro).

The project is introducing and exploring new non-linear (lateral) reasoning processes, as fundamental heuristic devices in problem solving. The initiative is based on recent results in neuroscience and in cognitive science, which have marked a breakthrough in our understanding of the roots of thinking and its relation to emotion and representation. It will involve the implementation of Diagrammatic Reasoning and Emotive Reasoning in building solution-possibilities based on abstract structural or affective features of problem cases. The project will build new models of lateral thinking, aiming at their implementation in learning processes.

Archelogos Projects (1991-present)

I am the Director of the Archelogos Projects, which I initiated with the collaboration of distinguished classical philosophers internationally. The Projects facilitate new ways of studying and researching philosophy. The first application involves the analysis of the works of Plato and Aristotle into their arguments by specialist experts in the field. The Argument Analyses are published electronically by Project Archelogos, at: www.archelogos.com.

Further Archelogos projects have centred on the intelligent organisation, search, and presentation of philosophical arguments in a digital environment, combining artificial intelligence techniques with innovative argumentation methods developed by the Archelogos Team.

The Archelogos Projects have been funded by the Carnegie Trust, the Leverhulme Trust, the Directorate of Education of the European Community, the Leventis Foundation, the Kostopoulos Foundation, the Michelis Foundation, and the Greek Ministry of Education.
