Career and Administrative work:

Teacher in Secondary Education from 1962 --with a three year educational leave during her scholarship-- to 1973. Member of the Research Centre for Greek Philosophy of the Academy of Athens (1973-1981). Teaching under contract at the University of Crete (1978-1981). Professor of Philosophy at the Department of Philosophy and Social Studies of the University of Crete (1982 -1997). Professor of Philosophy at the Department of Philosophy and History of Science of the University of Athens (1998-2002). Since 2002 she is a Professor Emerita of the Universities of Athens and of Crete since 2005. She has repeatedly been Chair of the Department of Philosophy and Social Studies of the University of Crete, and Chair of the Division of Philosophy of the same Department. In 1999-2000, she was elected Chair of the Division of Philosophy at the Department of Philosophy and History of Science of the University of Athens. She was also president of the Greek Philosophical Society and of the Greek State Scholarships Foundation. She was member of FISP C.D. since 1993 and vice-president 2003-2008, member of the Hellenic National Bioethics Committee and of the National Board for Medically Assisted Reproduction. She is member of the International Academy of Philosophy.

Academic Interests and Work:

Her academic interests are: Stoic philosophy, Philosophy of Human Rights, Ethics and Bioethics. Her academic works include more than 200 publications: 5 books—monographs, 4 Editorials of Conference Proceedings, more than 70 research papers on Greek and international journals and edited volumes --10 of them on Aristotle's ethics--, more than 100 papers (published or in press, in Proceedings of international and local conferences and edited volumes in Greece and abroad), 15 book reviews, two extensive participations in large scale collaborative projects, more than 15 articles in dictionaries and encyclopaedias. M. Dragona-Monachou has given many lectures in Greece and abroad (London, Cambridge, Princeton, Austin-Texas, Berkeley, Naples, Ericeira, Finland, Tokyo, India, etc.). She has participated in every World Congress of Philosophy since 1973 with contributed papers and/or presidencies, and has organized five conferences as chair of the Organizing Committee (2 International, 1 Balkan and 2 National).
