Christos Pechlivanidis was born in Thessaloniki, Greece. He read for his B.A. in the Faculty of Philosophy and Education (specialization: Philosophy) at the school of Philosophy of the Aristotle University of Thessaloniki. Under scholarships from the State's Scholarships Foundation and 'Alexander S. Onassis' Public Benefit Foundation, he did his postgraduate studies at the Aristotle University and took his M.A. in Systematic Philosophy (Philosophy of Science). The title of his M.A. thesis is "Scientific Realism and Antirealism: Bas van Fraassen's Empiricist Theory of Science and its Critique from a Scientific Realist point of view".

Meanwhile, he applied and won a scholarship from the Department of International Relations of Aristotle University for attending the Summer Intensive Course series of French Culture and Philosophy at the University of Marc Bloch II of Strasbourg, France. Under scholarships from 'Alexander S. Onassis' Public Benefit Foundation and the Research Committee of Aristotle University he took his Ph.D. (2010) in Ancient Philosophy and Philosophy of Science under the supervision of Prof. Demetra Sfendoni-Mentzou.
